2. With reference to paragraph 7 of the Minute of the meeting of the

the Sub-Committee held on 28 May 1996 when the Sub-Committee noted that funding amounting to \$31,000 would be allocated to Playschemes operating during the Summer, October and Easter School holidays in 1996/97, there was submitted a report (docketed) dated 13 June 1996 by the Chief Executive (1) intimating that applications have been received requesting financial assistance as detailed in Appendix 1 of the report;

(2) detailing a formulae for funding Playschemes in 1996/97 which would ensure that grant awards reflect the level of service provided; (3) suggesting that \$500 be top-sliced to accommodate the receipt of late applications, and (4) proposing that the Sub-Committee only approve funding for the Summer period thereby creating scope to consider further applications later in the year.
