There was submitted a report dated 3 October 1996 by the Chief Executive (1) advising that the Citizens' Advice Bureaux Service operated five offices within North Lanarkshire, had formed a North Lanarkshire Citizens' Advice Bureaux Committee and had submitted one application for funding for all the Bureaux; (2) Policy indicating that the application had been considered by the and Resources Committee at its meeting on 5 March 1996, as part of the budget process, and that \$152,000 had been awarded based on figures for 1994/95 supplied by the Bureaux Committee, and (3) pointing out that this allocation had not reflected the actual awards made by the former District Councils in 1995/96 and had resulted in a shortfall of funding in 1996/97 of \$12,839.

Decided: that a grant of \$12,839 be awarded to North Lanarkshire Citizens' Advice Bureaux Committee to meet the shortfall in funding for 1996/97.
