Alastair discussed to removal of the standard security and that his understanding is that both the land and community park will be sold. It was mentioned that boundaries have been asked to be put in place as well as a meeting 6 weeks prior to tonight which no response has been given. Alastair also advised members that he has obtained the title deeds. Alastair would like clarification on how the land will be monitored/maintained if Stuart Millan obtain it.

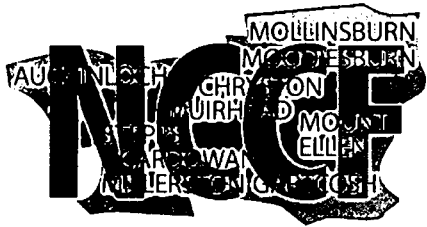
8. Local Area Partnership:
