(Temporary Traffic Management) Order 2016

On 26 September 2016 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, to be observed by vehicles (1) on Avon Street, Motherwell with travel restricted to one way northwards from its junction with B754 Airbles Road, northwards for a distance of 50 metres or thereby and (2) proposing to turn right from B754 Airbles Road to Avon Street or from Avon Street to B754 Airbles Road as detailed below.

Prohibition of Right Turn

From B754 Airbles Road to Avon Street

Vehicles on B754 Airbles Road wishing to turn right onto Avon Street should, alternatively, continue westwards on B754 Airbles Road, proceed around the roundabout exiting eastwards on B754 Airbles Road and proceeding eastwards on B754 Airbles Road to Avon Street.

From Avon Street to B754 Airbles Road

Vehicles on Avon Street wishing to turn right onto B754 Airbles Road should, alternatively, proceed north eastwards then north westwards on Avon Street, south westwards on A723 Hamilton Road to B754 Airbles Road.

Pedestrian access will be maintained at all times.

Vehicular access to adjacent properties will be maintained, where possible, by arrangement with the contractor, during the closure.

The Order will come into operation at 0001 hours on Monday, 10 October 2016 and will remain in operation until 2359 hours on Sunday, 23 October 2016.

(Temporary Traffic Management) Order 2016

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Avon Street, Motherwell) (Temporary Traffic Management) Order 2016” and shall be effective during the period from 0001 hours on Monday, the tenth day of October, Two thousand and sixteen until 2359 hours on Sunday, the twenty-third day of October, Two thousand and sixteen.
2. No person shall (1) drive or cause or permit to be driven any motor vehicle southwards on Avon Street, Motherwell from a point 50 metres or thereby north of its junction with B754 Airbles Road, southwards to its junction with B754 Airbles Road, and (2) turn right from B754 Airbles Road to Avon Street or from Avon Street to B754 Airbles Road as detailed below.

Prohibition of Right Turn

From B754 Airbles Road to Avon Street

Vehicles on B754 Airbles Road wishing to turn right onto Avon Street should, alternatively, continue westwards on B754 Airbles Road, proceed around the roundabout exiting eastwards on B754 Airbles Road and proceeding eastwards on B754 Airbles Road to Avon Street.

From Avon Street to B754 Airbles Road

Vehicles on Avon Street wishing to turn right onto B754 Airbles Road should, alternatively, proceed north eastwards then north westwards on Avon Street, south westwards on A723 Hamilton Road to B754 Airbles Road.

Pedestrian access will be maintained at all times.

Vehicular access to adjacent properties will be maintained, where possible, by arrangement with the contractor, during the closure.
