

**North Lanarkshire Council**

**High Road, Motherwell**

**(Temporary Road Closure) Order 2016**

On 26 September 2016 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on gas main replacement works) on High Road, Motherwell from its junction with A723 Hamilton Road north westwards for a distance of 30 metres of thereby by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the southeast side of the closure wishing to travel to the northwest side of the closure should proceed south westwards on A723 Hamilton Road, north westwards on Orchard Street, north eastwards on Ladywell Road, south eastwards on Farm Street and High Road to the northwest side of the closure.*

*Vehicles on the northwest side of the closure wishing to travel to the southeast side of the closure should proceed vice versa.*

Pedestrian access will be maintained at all times.

Vehicular access to adjacent premises will be maintained, where possible, by arrangement with the contractor, during the closure.

The Order will come into operation at 0001 hours on Saturday, 15 October 2016 and will remain in operation until 2359 hours on Sunday, 30 October 2016.

**(Temporary Road Closure) Order 2016**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (High Road, Motherwell) (Temporary Road Closure) Order 2016” and shall be effective during the period from 0001 hours on Saturday, the fifteenth day of October, Two thousand and sixteen until 2359 hours on Sunday, the thirtieth day of October, Two thousand and sixteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on gas main replacement works) on High Road, Motherwell from its junction with A723 Hamilton Road north westwards for a distance of 30 metres of thereby by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the southeast side of the closure wishing to travel to the northwest side of the closure should proceed south westwards on A723 Hamilton Road, north westwards on Orchard Street, north eastwards on Ladywell Road, south eastwards on Farm Street and High Road to the northwest side of the closure.*

*Vehicles on the northwest side of the closure wishing to travel to the southeast side of the closure should proceed vice versa.*

Pedestrian access will be maintained at all times.

Vehicular access to adjacent premises will be maintained, where possible, by arrangement with the contractor, during the closure.
