

**North Lanarkshire Council**  
**A8011 Central Way, Cumbernauld**  
**(Temporary Closure) Order 2016**

On 14 November 2016 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Town Centre Building Upgrading works) on A8011 Central Way, Cumbernauld from the extended line of the western kerb of Yule Way, south westwards to the extended line of the eastern kerb of MacIntosh Way/St Mungo's Way by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the north east side of the closure wishing to travel to the south west side of the closure should proceed southwards on Yule Way, south westwards on North Carbrain Road and north westwards on MacIntosh Way to the south west side of the closure.*

*Vehicles on the south west side of the closure wishing to travel to the north east side of the closure should proceed vice versa.*

Please note the road will only be closed in one direction at a time.

The Order, which will only be effective when signage is in place, will be operational from 2000 hours every day until 0600 hours the next day from 2000 hours on Monday, 28 November 2016 and will remain in operation until 0600 hours on Sunday, 19 February 2017.

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (A8011 Central Way, Cumbernauld) (Temporary Closure) Order 2016” and shall be effective during the period from 2000 hours until 0600 hours the next day from 2000 hours on Monday, the twenty-eighth day of November, Two thousand and sixteen until 0600 hours on Sunday, the nineteenth day of February, Two thousand and seventeen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Town Centre Building Upgrading works) on A8011 Central Way, Cumbernauld from the extended line of the western kerb of Yule Way, south westwards to the extended line of the eastern kerb of MacIntosh Way/St Mungo’s Way by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the north east side of the closure wishing to travel to the south west side of the closure should proceed southwards on Yule Way, south westwards on North Carbrain Road and north westwards on MacIntosh Way to the south west side of the closure.*
