**Campsie Crescent, Airdrie**

**(Temporary Closure) Order No 2 2016**

On 19 September 2016 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on repair works to the retaining wall) on Campsie Crescent, Airdrie from its junction with Park Street, north eastwards for a distance of 95 metres or thereby by reason of works being executed on or near that location.

*Alternative routes: Vehicles on Park Street on the south west side of the closure wishing to travel to Campsie Crescent on the north east side of the closure should proceed south eastwards on Park Street, north eastwards on Aitchison Street, north westwards on Wilson Street and south westwards on Campsie Crescent to the north east side of the closure.*

*Vehicles on Campsie Crescent on the north east side of the closure wishing to travel to Park Street should proceed vice versa.*

Pedestrian access will be maintained at all times.

This Order, which continues the restrictions currently in place by virtue of similar Orders made by the Council on Monday, 12 October 2015 and Monday, 14 March 2016, will come into operation at 2359 hours on Saturday, 1 October 2016 and will remain in operation until 2359 hours on Sunday, 30 April 2017.

**(Temporary Closure) Order No 2 2016**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Campsie Crescent, Airdrie) (Temporary Road Closure) Order No 2 2016” and continues restrictions currently in place by virtue of similar Orders made by the Council on Monday, the twelfth day of October, Two thousand and fifteen and Monday, the fourteenth day of March, Two thousand and sixteen, shall be effective during the period from 2359 hours on Saturday, the first day of October, Two thousand and sixteen until 2359 hours on Sunday, the thirtieth day of April, Two thousand and seventeen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on repair works to the retaining wall) on Campsie Crescent, Airdrie from its junction with Park Street, north eastwards for a distance of 95 metres or thereby by reason of works being executed on or near that location.

*Alternative routes: Vehicles on Park Street on the south west side of the closure wishing to travel to Campsie Crescent on the north east side of the closure should proceed south eastwards on Park Street, north eastwards on Aitchison Street, north westwards on Wilson Street and south westwards on Campsie Crescent to the north east side of the Closure.*

*Vehicle on Campsie Crescent on the north east side of the closure wishing to travel to Park Street should proceed vice versa.*

Pedestrian access will be maintained at all times.
