**1. Purpose of Report**

The Committee is asked to approve the introduction of a Traffic Regulation Order which proposes to establish disabled persons' parking places at various locations throughout the central and northern areas of North Lanarkshire, as detailed in the Appendix to the report, in terms of the Disabled Persons' Parking Places (Scotland) Act 2009 and the Road Traffic Regulations Act 1984.

**2. Report**

2.1. The Scottish Parliament introduced the Disabled Persons' Parking Places (Scotland) Act 2009 which imposed responsibilities on the Council's Roads Authority.


This legislation changed the standing of disabled persons' parking places from advisory to mandatory, which meant that all such places are now required to be covered by a Traffic Regulation Order.

2.2. The Council has advertised its proposals to introduce the North Lanarkshire Council (Various Streets, Central and Northern Areas) (Disabled Persons' Parking Places) Order by public advertisement, to which no objections were received. In addition, the Chief Constable of Police Scotland, the Road Haulage Association Limited, the Freight Transport Association Limited, the North Lanarkshire Disability Forum and local Councillors as well as other organisations have all been consulted, each of whom have offered no objections to the proposals.

2.3. Each disabled parking place covered by the proposed Order is detailed in the Appendix and has been visited by an Officer from Roads and Transportation who has ensured (a) that each proposed parking place is in a safe location; (b) that it is exactly where the applicant has asked it to be placed, and (c) that the applicant is a blue badge holder.

**3. Recommendation**

That the Committee approve the introduction of the North Lanarkshire Council (Various Streets, Central and Northern Area) (Disabled Persons Parking Places) Order, as detailed in the Appendix to the report.
