1. The Committee noted that there were no declarations of interest.

**LANARKSHIRE EDUCATIONAL TRUST SCHEME 2016/17**

2. There was submitted a report dated 20 October 2016 by the Head of Education (Skills, Lifelong Learning and Youth Employment), NLC (1) advising that the total disbursement of the Lanarkshire Educational Trust Fund for the first tranche of applications for grant from the Trust Scheme for 2016/17 was £35,711.52, and (2) setting out, in the Appendix to the report, recommendations for the second tranche of applications for grant under the Scheme.

Thereon, the Community Learning and Development Manager orally advised that since the publication of the agenda for this meeting, information had been received in respect of applications IN09, IN10 and IN14, and that, as a result, it was now recommended that grant awards of £750 be made in respect of each of these applications.

- (2) that the second tranche of applications for grant under the Trust Scheme be dealt with as detailed in the Annex to this Minute.
