**B819 Westerhill Road, Bishopbriggs**

**Temporary Closure Order 2018**

On 21 February 2018 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the Construction of a New Road and Cycle Track) on B819 Westerhill Road, Bishopbriggs from the extended line of the northern kerb of Wester Cleddens Road, northwards then westwards for a distance of 544 metres or thereby to the boundary with East Dunbartonshire Council, by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the south side of the closure wishing to travel to the north west side of the closure should proceed north westwards then south westwards on Wester Cleddens Road, south westwards on Crosshill Road, north eastwards on A803 Kirkintilloch Road and eastwards then south eastwards on Westerhill Road to the north west side of the closure.*

*Vehicles on the north west side of the closure wishing to travel to the south side of the closure should proceed vice versa.*

Pedestrian access will not be maintained.

The Order will come into operation at 0001 hours on Friday, 2 March 2018 and will remain in operation until 1800 hours on Thursday, 31 May 2018.

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (B819 Westerhill Road, Bishopbriggs) (Temporary Closure) Order 2018” and shall be effective during the period from 0001 hours on Friday, the second day of March, Two thousand and eighteen until 1800 hours on Thursday, the thirty first day of May, Two thousand and eighteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the Construction of a New Road and Cycle Track) on B819 Westerhill Road, Bishopbriggs from the extended line of the northern kerb of Wester Cleddens Road, northwards then westwards for a distance of 544 metres or thereby to the boundary with East Dunbartonshire Council, by reason of works being executed on or near that location.
