

North Lanarkshire Council
Woodside Street, Coatbridge
(Temporary Road Closure) Order 2018

On 12 March 2018 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on electrical utility works) on Woodside Street, Coatbridge from its junction with A89 Bank Street to its junction with Allan Street by reason of works being executed on or near that location.

Alternative Routes: Vehicles on the north side of the closure wishing to travel to the south side of the closure should proceed north eastwards on A89 Bank Street, south eastwards on A89 South Circular Road, southwards on A725 Coatbank Street and A725 Whifflet Street, south westwards on School Street, westwards on Old Monkland Road then northwards on Woodside Street to the south side of the closure.

Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed vice versa.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the closure.

The Order will come into operation at 0001 hours on Friday, 30 March 2018 and will remain in operation until 2359 hours on Sunday, 15 April 2018.

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Woodside Street, Coatbridge) (Temporary Road Closure) Order 2018” and shall be effective during the period from 0001 hours on Friday, the thirtieth day of March, Two thousand and eighteen until 2359 hours on Sunday, the fifteenth day of April, Two thousand and eighteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on electrical utility works) on Woodside Street, Coatbridge from its junction with A89 Bank Street to its junction with Allan Street by reason of works being executed on or near that location.

Alternative Routes: Vehicles on the north side of the closure wishing to travel to the south side of the closure should proceed north eastwards on A89 Bank Street, south eastwards on A89 South Circular Road, southwards on A725 Coatbank Street and A725 Whifflet Street, south westwards on School Street, westwards on Old Monkland Road then northwards on Woodside Street to the south side of the closure.

Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed vice versa.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the closure.
