STRATEGIC PLANNING

**COMMUNITY ALARM SERVICE - REVIEW OF ELIGIBILITY CRITERIA AND FUTURE SERVICE
PLANNING**

8. With reference to paragraph 14 of the Minute of the meeting of this Board held 18 July 2017, when it was agreed that a consultation with stakeholders on a new criteria for eligibility to access the Community Alarm Service be undertaken, there was submitted a report dated 27 March 2018 by the Chief Accountable Officer (1) advising (a) that the Community Alarm Service, registered with the Care Inspectorate, currently provides service to approximately 10,000 individuals living within North Lanarkshire with the majority of these individuals living within their own homes, including 1,400 who reside within a sheltered housing complex and provided to all care groups and was currently automatic, on request, if the person was aged 75 years plus and living alone; (b) that the service operates 24 hours a day, 365 days per year, and provides a response to those in an urgent situation who may require support with personal care, a fall or an illness, and (c) that referrals were received from a range of sources including individuals and carers, community nursing, GPs, hospitals, hospices, Social Work team, Housing and Police Scotland; (2) setting out the scope of the service together with service challenges; (3) detailing the consultation progress and the operation of the service, as contained within the Appendices to the report, and (4) recommending that the Board (a) approve the proposals that the eligibility to access the Community Alarm Service be changed from the current criteria, whereby the majority of service users access the service based on age linked criteria to provision based on needs assessment, to align with the wider prioritisation framework used for other Social Work services; (b) approve the implementation of needs based assessment for the service from June 2018, noting that this would be supported by the Implementation Plan; (c) agree the establishment of a Review Group to address wider issues impacting on the service as outlined within the report, and (d) request that further reports be brought to this Board in October 2018 to update on

the work and proposals for any further changes required to ensure the effectiveness and sustainability of the future service.

Decided: that the recommendations contained within the report be approved and noted.

NEW MODEL OF HOME SUPPORT

9. There was submitted a report dated 8 March 2018 by the Chief Accountable Officer (1) seeking approval for a new model of home support, as contained within the Appendix to the report; (2) detailing the background relative thereto, and (3) recommending that the Board (a) approve the new home support model to include the viable outputs of the cross party working group, as noted in Appendix 1 of the report; (b) request an Implementation Plan with timelines to be co-produced with staff and trade unions by the end of April 2018; (c) approve that Home Support staff who choose to pursue their SVQ2 qualification are supported to do so by October 2020; (d) agree to monitor funding of the new home support model through the Performance, Finance and Audit Committee and build on the financial projections outlined in Appendix 1 of the Board's long term financial plan; (e) monitor the performance of the new home support model for two years through the Performance, Finance and Audit Committee, and (f) request ongoing engagement with service users through the implementation process and review stages of the home support model.

Councillor Stubbs asked that it be recorded that he could not support the recommendations due to concerns regarding employment issues.

Decided: that the recommendations contained within the report be approved and noted.
