

North Lanarkshire Council
Various Streets, Airdrie
(Temporary Road Closure) Order 2018

On 11 June 2018 the North Lanarkshire Council made the above-named Order under Section 16A of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Airdrie Fair Day) on the undernoted roads by reason of works being executed on or near those locations.

Road Closures

Broomknoll Street, northbound carriageway only from its junction with A89 Weaver Road, northwards to the extended line of the northern kerb of Callon Street, a distance of 100 metres or thereby.

Broomknoll Street from the extended line of the northern kerb of Callon Street, northwards to the extended line of the southern kerb of Graham Street, a distance of 49 metres or thereby.

Bank Street from the extended line of the northern kerb of Graham Street, northwards to the extended line of the northern kerb of Hallcraig Street, a distance of 123 metres or thereby.

Hallcraig Street from the extended line of the eastern kerb of Buchanan Street, eastwards to the extended line of the eastern kerb of Bank Street, a distance of 109 metres or thereby.

Mill Street from its junction with Hallcraig Street, north eastwards for a distance of 72 metres or thereby.

Mill Loan from the extended line of the northern kerb of Mill Street, north westwards for a distance of 57 metres or thereby.

Anderson Street from its junction with Bank Street, eastwards to its junction with Wellwynd, a distance of 119 metres or thereby.

South Bridge Street from the extended line of the northern kerb of Hallcraig Street, north westwards to the extended line of the southern kerb of A8010 High Street, a distance of 190 metres or thereby.

Buchanan Street from its junction with Hallcraig Street, southwards to its junction with Graham Street, a distance of 80 metres or thereby.

Graham Street from the extended line of the eastern kerb of Buchanan Street, westwards to the extended line of the eastern kerb of Broomknoll Street, a distance of 96 metres or thereby.

Stirling Street, eastbound carriageway only from the extended line of the eastern kerb of A89 Weaver Road, north eastwards to the extended line of the western kerb of Wellwynd, a distance of 119 metres or thereby.

Stirling Street, from the extended line of the eastern kerb of Wellwynd, eastwards to the extended line of the western kerb of Bank Street, a distance of 108 metres or thereby.

Alternative routes: Vehicles on A89 Alexander Street on the east side of Stirling Street wishing to travel to Wellwynd should travel southwards and eastwards on A89 Weaver Road, northwards on A89 Gartlea Road, eastwards on A89 Graham Street and A89 Clark Street, north eastwards then north westwards on A73 Motherwell Street and south westwards on A8010 Black Street, A8010 Aitken Street, A8010 Chapel Street, A8010 East High Street and A8010 High Street to Wellwynd.

Vehicles on Wellwynd wishing to travel to A89 Alexander Street should proceed vice versa.

Vehicles on A89 Weaver Road, approaching Broomknoll Street, wishing to travel to Wellwynd should proceed eastwards on A89 Weaver Road, northwards on A89 Gartlea Road, eastwards on A89 Graham Street and A89 Clark Street, north eastwards then north westwards on A73 Motherwell Street, south westwards on A8010 Black Street, A8010 Aitken Street, A8010 Chapel Street, A8010 East High Street and A8010 High Street to Wellwynd.

Vehicles on Wellwynd wishing to travel to A89 Weaver Road should proceed vice versa.

Vehicles on Hallcraig Street at the north western side of the closure wishing to travel to Wellwynd should proceed eastwards on Hallcraig Street, southwards on Baillies Lane, eastwards on A89 Graham Street and A89 Clark Street, north eastwards then north westwards on A73 Motherwell Street, south westwards on A8010 Black Street, A8010 Aitken Street, A8010 Chapel Street, A8010 East High Street and A8010 High Street to Wellwynd.

Vehicles on Wellwynd wishing to travel to Hallcraig Street at the north western side of the closure should proceed vice versa.

Vehicles on Broomknoll Street south of A89 Weaver Road wishing to travel to Wellwynd should proceed eastwards on A89 Weaver Road, northwards on A89 Gartlea Road, eastwards on A89 Graham Street and A89 Clark Street, north eastwards then north westwards on A73 Motherwell Street, south westwards on A8010 Black Street, A8010 Aitken Street, A8010 Chapel Street, A8010 East High Street and A8010 High Street to Wellwynd.

Vehicles on Wellwynd wishing to travel to Broomknoll Street should proceed vice versa.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the closure.

The Order will come into operation at 0001 hours and will remain in operation until 2359 hours on Saturday, 30 June 2018.
