

North Lanarkshire Council
Wyndford Road, Cumbernauld
(Temporary Road Closure) Order 2018

On 6 August 2018 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing) on Wyndford Road, Cumbernauld from the extended line of the northern kerb of Castlecary Road to the extended line of the northern kerb of Napier Road by reason of works being executed on or near that location.

Alternative routes: Vehicles on the south side of the closure wishing to access the northwest side of the closure should proceed via Castlecary Road and Napier Road.

Vehicles on the northwest side of the closure wishing to travel to the south side of the closure should proceed vice versa.

Vehicles on the south side of the closure wishing to travel to the northeast side of the closure should proceed via Castlecary Road and Tollpark Place.

Vehicles on the northeast side of the closure wishing to travel to the south side of the closure should proceed vice versa.

The Order will come into operation at 0900 hours on Saturday, 25 August 2018 and will remain in operation until 2359 hours on Friday, 31 August 2018.

(Temporary Road Closure) Order 2018

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Wyndford Road, Cumbernauld) (Temporary Road Closure) Order 2018” and shall be effective during the period from 0900 hours on Saturday, the twenty fifth day of August, Two thousand and eighteen until 2359 hours on Friday, the thirty first day of August, Two thousand and eighteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing) on Wyndford Road, Cumbernauld from the extended line of the northern kerb of Castlecary Road to the extended line of the northern kerb of Napier Road by reason of works being executed on or near that location.

Alternative routes: Vehicles on the south side of the closure wishing to access the northwest side of the closure should proceed via Castlecary Road and Napier Road.

Vehicles on the northwest side of the closure wishing to travel to the south side of the closure should proceed vice versa.

Vehicles on the south side of the closure wishing to travel to the northeast side of the closure should proceed via Castlecary Road and Tollpark Place.

Vehicles on the northeast side of the closure wishing to travel to the south side of the closure should proceed vice versa.
