Gartgill Road, Coatbridge (Heatherbell Level Crossing)

(Temporary Road Closure) Order 2018

On 20 August 2018 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on level crossing repairs) on Gartgill Road, Coatbridge from B804 Gartliston Road to Wilton Street by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure wishing to travel to the south side of the closure should proceed southward on B804 Gartliston Road, B804 Coltswood Road, B804 Dunbeth Road, A725 Coatbank Street and A725 Whifflet Street, north westwards on B753 Dundyvan Road, south westwards on A89 Bank Street, northwards on Blair Road, north westwards on Lomond Road and north eastwards on Wilton Street to the south side of the closure.

Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed vice versa.

The Order will be completed over two phases from 2100 hours on Saturday, 8 September 2018 until 0600 hours on Monday, 10 September 2018 and from 2100 hours on Saturday, 15 September 2018 until 0600 hours on Monday, 17 September 2018.

(Temporary Road Closure) Order 2018

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Gartgill Road, Coatbridge) (Heatherbell Level Crossing) (Temporary Road Closure) Order 2018” and shall be effective over two phases from 2100 hours on Saturday, the eighth day of September 2018 until 0600 hours on Monday, the tenth day of September 2018 and from 2100 hours on Saturday, fifteenth day of September 2018 until 0600 hours on Monday, the seventeenth day of September 2018.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on level crossing repairs) on Gartgill Road, Coatbridge from B804 Gartliston Road to Wilton Street by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure wishing to travel to the south side of the closure should proceed southward on B804 Gartliston Road, B804 Coltswood Road, B804 Dunbeth Road, A725 Coatbank Street and A725 Whifflet Street, north westwards on B753 Dundyvan Road, south westwards on A89 Bank Street, northwards on Blair Road, north westwards on Lomond Road and north eastwards on Wilton Street to the south side of the closure.
