

**North Lanarkshire Council**  
**A775 Edinburgh Road, Newhouse**  
**(Temporary Road Closure) Order 2018**

On 1 October 2018 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing) on A775 Edinburgh Road, Newhouse from the extended line of the western kerb of A73 Carlisle Road westwards for a distance of 270 metres or thereby by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the east side of the closure wishing to travel to the west side of the closure should proceed north westwards on A73 Carlisle Road, westwards on A8 Glasgow and Edinburgh Road (APR), southwards on A8 Link Road (APR), south westwards on B799 Bo'ness Road, north eastwards on A775 Edinburgh Road to the west side of the closure.*

*Vehicles on the west side of the closure wishing to travel to the east side of the closure should proceed vice versa.*

Pedestrian access will be maintained at all times.

The Order will be completed over two phases from 0001 hours on Saturday, 20 October 2018 until 2359 hours on Sunday, 21 October 2018 and from 0001 hours on Saturday, 27 October 2018 until 2359 hours on Sunday, 28 October 2018.

**(Temporary Road Closure) Order 2018**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Edinburgh Road, Newhouse) (Temporary Road Closure) Order 2018” and shall be effective over two phases from 0001 hours on Saturday, the twentieth day of October, Two thousand and eighteen until 2359 hours on Sunday, the twenty first day of October, Two thousand and eighteen and 0001 hours on Saturday, the twenty seventh day of October Two thousand and eighteen until 2359 hours on Sunday, the twenty eighth day of October, Two thousand and eighteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing) on A775 Edinburgh Road, Newhouse from the extended line of the western kerb of A73 Carlisle Road westwards for a distance of 270 metres or thereby by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the east side of the closure wishing to travel to the west side of the closure should proceed north westwards on A73 Carlisle Road, westwards on A8 Glasgow and Edinburgh Road (APR), southwards on A8 Link Road (APR), south westwards on B799 Bo'ness Road, north eastwards on A775 Edinburgh Road to the west side of the closure.*
