

**North Lanarkshire Council**  
**Gartgill Road, Coatbridge**  
**(Temporary Closure) Order 2019**

On 21 January 2019 the North Lanarkshire Council made the above-named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on rail bridge maintenance works) on Gartgill Road, Coatbridge from Wilton Street to Gartsherrie Road by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the north side of the closure should proceed via Gartgill Road, Wilton Street, Lomond Road, Gartsherrie Road and Gartgill Road.*

*Vehicles on the south side of the closure should proceed vice versa.*

Pedestrian access will be maintained at all times.

The Order, which continues the restrictions currently in place by virtue of a similar Order made by the Council on Monday, 5 November 2018, will come into operation at 2301 hours on Thursday, 7 February 2019 and will remain in operation until 2300 hours on Thursday, 28 February 2019.

**(Temporary Closure) Order 2019**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Gartgill Road, Coatbridge) (Temporary Closure) Order 2019” which continues the restrictions currently in place by virtue of a similar Order made by the Council on Monday, the fifth day of November, Two thousand and eighteen, and shall be effective during the period from 2301 hours on Thursday, the seventh day of February, Two thousand and nineteen until 2300 hours on Thursday, the twenty-eighth day of February, Two thousand and nineteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on rail bridge maintenance works) on Gartgill Road, Coatbridge from Wilton Street to Gartsherrie Road by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the north side of the closure should proceed via Gartgill Road, Wilton Street, Lomond Road, Gartsherrie Road and Gartgill Road.*
