**Footpaths on Arden Grove and Balmalloch Road, Kilsyth**

**(Temporary Prohibition of Pedestrian Movement) Order 2019**

On 16 July 2019 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to proceed on foot (with the exception of pedestrians engaged on power supply upgrade works) on the remote footpaths between 36-38 Arden Grove and 141-143 Balmalloch Road, Kilsyth by reason of works being executed on or near that location.

*Alternative routes: Pedestrians on the north side of the closure wishing to access the south side of the closure should proceed westwards on Arden Grove, southwards on Livingstone Park and eastwards on Balmalloch Road.*

*Pedestrians on the south side of the closure wishing to access the north side of the closure should proceed vice versa.*

The Order will come into operation at 0800 hours on Monday, 29 July 2019 and will remain in operation until 1800 hours on Sunday, 11 August 2019.

### Footpaths on Arden Grove and Balmalloch Road, Kilsyth

#### (Temporary Prohibition of Pedestrian Movement) Order 2019

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Footpaths on Arden Grove and Balmaclloch Road, Kilsyth) (Temporary Prohibition of Pedestrian Movement) Order 2019” and shall be effective during the period from 0800 hours on Monday, the twenty-ninth day of July, Two thousand and nineteen until 1800 hours on Sunday, the eleventh day of August, Two thousand and nineteen.
2. No person shall proceed on foot (with the exception of pedestrians engaged on power supply upgrade works) on the remote footpaths between 36-38 Arden Grove and 141-143 Balmalloch Road, Kilsyth by reason of works being executed on or near that location.

*Alternative routes: Pedestrians on the north side of the closure wishing to access the south side of the closure should proceed westwards on Arden Grove, southwards on Livingstone Park and eastwards on Balmalloch Road.*

*Pedestrians on the south side of the closure wishing to access the north side of the closure should proceed vice versa.*
