Albert Road and Victoria Road, Harthill

(Temporary Waiting and Loading Restrictions) Order 2020

On 27 January 2020 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any motor vehicle to wait or load at any time (with the exception of vehicles engaged on the installation of utilities) on the undernoted roads by reason of works being executed on or near those locations.

Albert Road, Harthill from its junction with Victoria Road, southwards for a distance of 40 metres or thereby on both sides of the road.

Victoria Road, Harthill from its junction with Victoria Street, westwards to its junction with Albert Road, a distance of 140 metres or thereby on both sides of the road.

Pedestrian access will be maintained at all times.

The Order will come into operation at 0001 hours on Monday, 10 February 2020 and will remain in operation until 2359 hours on Sunday, 1 March 2020.

(Temporary Waiting and Loading Restrictions) Order 2020

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Albert Road and Victoria Road, Harthill) (Temporary Waiting and Loading Restrictions) Order 2020” and shall be effective during the period from 0001 hours on Monday, the tenth day of February, Two thousand and twenty until 2359 hours on Sunday, the first day of March, Two thousand and twenty.
2. No motor vehicle is permitted to wait or load at any time (with the exception of vehicles engaged on the installation of utilities) on the undernoted roads by reason of works being executed on or near those locations.

Albert Road, Harthill from its junction with Victoria Road, southwards for a distance of 40 metres or thereby on both sides of the road.

Victoria Road, Harthill from its junction with Victoria Street, westwards to its junction with Albert Road, a distance of 140 metres or thereby on both sides of the road.

Pedestrian access will be maintained at all times.
