

**North Lanarkshire Council**  
**Carnbroe Road, Carnbroe**  
**(Temporary Speed Limit) Order 2019**

On 7 November 2019 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 mph (with the exception of vehicles engaged on facilitating safe work zones for spine road associated with a residential update) on Carnbroe Road, Carnbroe from a point 126 metres northwards of the east bound carriageway of the A8 Glasgow and Edinburgh Road, to a point, northwards for a distance of 625 metres or thereby by reason of works being executed on or near that location.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the closure.

The Order will come into operation at 0001 hours on Monday, 18 November 2019 and will remain in operation until 2359 hours on Saturday, 30 May 2020.

**Carnbroe Road, Carnbroe**  
**(Temporary Speed Limit) Order 2019**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Carnbroe Road, Carnbroe) (Temporary Speed Limit) Order 2019” and shall be effective during the period from 0001 hours on Monday, the eighteenth day of November, Two thousand and nineteen until 2359 hours on Saturday, the thirtieth day of May, Two thousand and twenty.
2. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 mph (with the exception of vehicles engaged on facilitating safe work zones for spine road associated with a residential update) on Carnbroe Road, Carnbroe from a point 126 metres northwards of the east bound carriageway of the A8 Glasgow and Edinburgh Road, to a point, northwards for a distance of 625 metres or thereby by reason of works being executed on or near that location.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the closure.
