Old Biggar Road, Airdrie
(Temporary Road Closure) Order 2019

On 28 October 2019 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on scottish water works) on Old Biggar Road, Airdrie from the extended east kerb line of B8039 Stirling Road, southwards to the extended north kerb line of B803 Greengairs Road by reason of works being executed on or near that location.

Alternative routes: Vehicles on B8039 Stirling Road at the north side of the closure wishing to travel to B803 Greengairs Road at the south side of the closure should travel generally southwards on B8039 Stirling Road, southwards on A73 Stirling Road, eastwards on B803 Greengairs Road, to the south side of the closure.

Vehicles on B803 Greengairs Road at the south side of the closure wishing to travel to B8039 Stirling Road at the north side of the closure should travel generally westwards on B803 Greengairs Road, northwards on A73 Stirling Road, eastwards on Blackbog Road, southwards on B8039 Stirling Road, to the north side of the closure.

Pedestrian access will be maintained, where practicable, during the closure.

The Order will come into operation at 0001 hours on Wednesday, 13 November 2019 and will remain in operation until 2359 hours on Friday, 29 November 2019.

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Old Biggar Road, Airdrie) (Temporary Road Closure) Order 2019” and shall be effective during the period from 0001 hours on Wednesday, the thirteenth day of November, Two thousand and nineteen until 2359 hours on Friday, the twenty-ninth day of November, Two thousand and nineteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on scottish water works) on Old Biggar Road, Airdrie from the extended east kerb line of B8039 Stirling Road, southwards to the extended north kerb line of B803 Greengairs Road by reason of works being executed on or near that location.

Alternative routes: Vehicles on B8039 Stirling Road at the north side of the closure wishing to travel to B803 Greengairs Road at the south side of the closure should travel generally southwards on B8039 Stirling Road, southwards on A73 Stirling Road, eastwards on B803 Greengairs Road, to the south side of the closure.

Vehicles on B803 Greengairs Road at the south side of the closure wishing to travel to B8039 Stirling Road at the north side of the closure should travel generally westwards on B803 Greengairs Road, northwards on A73 Stirling Road, eastwards on Blackbog Road, southwards on B8039 Stirling Road, to the north side of the closure.

Pedestrian access will be maintained, where practicable, during the closure.
