Bell Street and Hattonrigg Road, Bellshill
(Temporary Waiting Restrictions) Order 2020

On 23 March 2020 the North Lanarkshire Council made the above-named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any motor vehicle to wait between the hours of 8am and 6pm (with the exception of vehicles engaged on Scottish Water works) on Bell Street and Hattonrigg Road, Bellshill, on both sides of the roads, as detailed undernoted by reason of works being executed on or near those locations.

Bell Street, Bellshill over its entire length.

Hattonrigg Road, Bellshill, from a point 25 metres north of its junction with Bell Street, southwards for a distance of 50 metres or thereby.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the works.

The Order, will come into operation at 0800 hours on Monday, the sixth day of April 2020 and will remain in operation until 1800 hours on Monday, the twentieth day of April 2020.

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Bell Street and Hattonrigg Road, Bellshill) (Temporary Waiting Restrictions) Order 2020” and shall be effective during the period from 0800 hours on Monday, the sixth day of April, Two thousand and twenty until 1800 hours on Monday, the twentieth day of April, Two thousand and twenty.
2. No motor vehicle is permitted to wait between the hours of 8am and 6pm (with the exception of vehicles engaged on Scottish Water works) on Bell Street and Hattonrigg Road, Bellshill, on both sides of the roads, as detailed undernoted by reason of works being executed on or near those locations.

Bell Street, Bellshill over its entire length.

Hattonrigg Road, Bellshill, from a point 25 metres north of its junction with Bell Street, southwards for a distance of 50 metres or thereby.

Pedestrian access will be maintained at all times.

Vehicular access will be maintained, where practicable, during the works.
