A803, QUEENZIEBURN TO KILSYTH

30 MPH AND 40 MPH SPEED LIMITS (VARIATION) ORDER 2020

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as "The North Lanarkshire Council (A803, Queenzieburn to Kilsyth) Proposed (30 MPH and 40 MPH Speed Limits) (Variation) Order 2020" and shall come into operation Monday, the thirteenth day of April, Two thousand and twenty.
2. Upon the coming into effect of this Order, the Orders specified in the Schedule to this Order shall have effect, subject to amendments specified in that Schedule.

ORDER TO BE AMENDED

The North Lanarkshire Council (A803, Queenzieburn to Kilsyth) (30 MPH and 40 MPH Speed Limit)
Order 2003

Schedule I (30 MPH Speed Limit)

Add

That length of A803 Kilsyth Road from a point 286 metres or thereby east of the extended east kerblines of Dumbreck Terrace, westwards then south westwards to a point 111 metres or thereby, south west of the extended west kerblines of Mill Road, a distance of 684 metres or thereby.

Schedule II (40 MPH Speed Limit)

Add

That length of A803, from a point 375 metres or thereby, west of the extended west kerblines of Whin Loan, westwards to a point 885 metres or thereby, west of the extended west kerblines of Whin Loan, a distance of 510 metres or thereby.

Amend From

That length of the A803 from a point 35 metres or thereby, west of the extended west kerblines of Mill Road, Queenzieburn extending in a north easterly direction to a point 112 metres or thereby, west of the extended west kerblines of Laird's Hill Place, Kilsyth, a distance of 1,001 metres or thereby.

Amend To

That length of the A803 from a point 286 metres or thereby, east of the extended east kerblines of Dumbreck Terrace, Queenzieburn extending in a north easterly direction to a point 112 metres or thereby, west of the extended west kerblines of Laird's Hill Place, Kilsyth, a distance of 503 metres or thereby.
