Various Streets, Motherwell

(Temporary Road Closure) Order 2020

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Various Streets, Motherwell) (Temporary Road Closure) Order 2020" and shall be effective during the period from 0001 hours on Monday, the twenty-ninth day of June, Two thousand and twenty until 2359 hours on Tuesday, the twenty-eighth day of December, Two thousand and twenty-one.
2. No person shall drive or cause or permit to be driven any motor vehicle on the wundenoted roads by reason of protecting public health and promoting social distancing on or near those locations.

Bothwellhaugh Road, Motherwell from its junction with the Strathclyde Park Spine Road to a point 473 metres south east of the junction with McCallum Gardens, a distance of 742 metres or thereby.

Alternative routes: Vehicles on the south side of the closure should proceed north-westwards on the Strathclyde Park Spine Road, circulate A725 Raith Interchange, north-eastwards on A725 Bellshill Bypass, northwards on B7070 Hamilton Road, eastwards on Farmgate Square, south westwards then eastwards on Crofthead Crescent, southwards on Lawmuir Road, eastwards on Community Road, southwards on McCallum Gardens then southwards on Bothwellhaugh Road to the north side of the closure.

Vehicles on the north side should proceed vice versa.

Pedestrian and bicycle access will be maintained, at all times during the closure.

Dalziel Drive, Motherwell from a point 7 metres south of its junction with Heron View southwards and westwards to its termination, a distance of 993 metres or thereby.

There are no alternative routes.

Pedestrian and bicycle access will be maintained at all times.

Residents and Service access will be maintained at all times.

Ladywell Road, Motherwell from its junction with Neilsland Drive to its junction with Strathclyde Road, a distance of 77 metres or thereby.

Alternative routes: Vehicles on the north side of the closure should proceed south eastwards along Neilsland Drive, south westwards along Haughview Road and north westwards on Strathclyde Road to the south side of the closure.

Vehicles on the south side of the closure should proceed vice versa.

Pedestrian and bicycle access will be maintained at all times.

Manse Road, Motherwell from the junction with John Murray Court, southwards to its termination, a distance of 465 metres or thereby.

There are no alternative routes.

Pedestrian and bicycle access will be maintained at all times.

Residents and Service access will be maintained at all times.
