**(Temporary Road Closure) Order 2021**

On 6 January 2021 the North Lanarkshire Council made the above-named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the removal of pedestrian gantry) on Blair Road, Coatbridge from Espieside Crescent to Corsewall Street by reason of works being executed on or near that location.

*Alternative routes: Vehicles of a height up to 15' 0" should proceed via Blair Road, Gartsherrie Road, B803 Sunnyside Road, A89 Bank Street and Blair Road.*

*Vehicles of a height in excess of 15' 0" should proceed via Blair Road, Townhead Road, A752 Gartcosh Road, A752 Coatbridge Road, B806 Gartloch Road, B765 Stepps Road, A8 Edinburgh Road, A8 Glasgow and Edinburgh Road, A89 Coatbridge Road, A89 Glasgow Road, A89 Bank Street and Blair Road.*

Pedestrian access will be maintained at all times.

The Order, which will only be effective on Saturdays and Sundays, will come into operation at 1900 hours on Saturday, 16 January 2021 and will remain in operation until 0700 hours on Sunday, 31 January 2021.

**(Temporary Road Closure) Order 2021**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Blair Road, Coatbridge) (Temporary Road Closure) Order 2021" and shall be effective on Saturdays and Sundays only, during the period from 1900 hours on Saturday, the sixteenth day of January, Two thousand and twenty-one until 0700 hours on Sunday, the thirty-first day of January, Two thousand and twenty-one.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the removal of pedestrian gantry) on Blair Road, Coatbridge from Espieside Crescent to Corsewall Street by reason of works being executed on or near that location.

*Alternative routes: Vehicles of a height up to 15' 0" should proceed via Blair Road, Gartsherrie Road, B803 Sunnyside Road, A89 Bank Street and Blair Road.*

*Vehicles of a height in excess of 15' 0" should proceed via Blair Road, Townhead Road, A752 Gartcosh Road, A752 Coatbridge Road, B806 Gartloch Road, B765 Stepps Road, A8 Edinburgh Road, A8 Glasgow and Edinburgh Road, A89 Coatbridge Road, A89 Glasgow Road, A89 Bank Street and Blair Road.*

Pedestrian access will be maintained at all times.
